



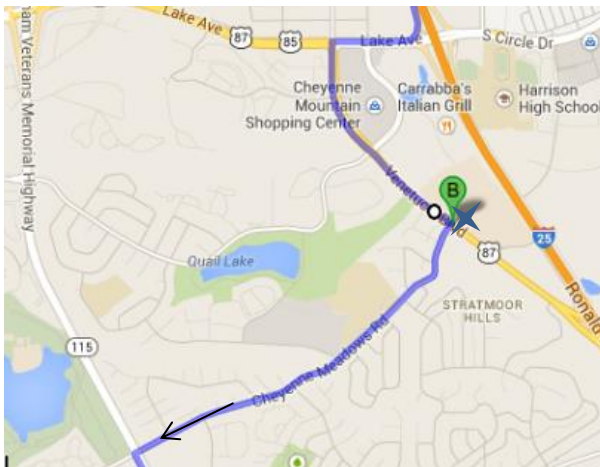
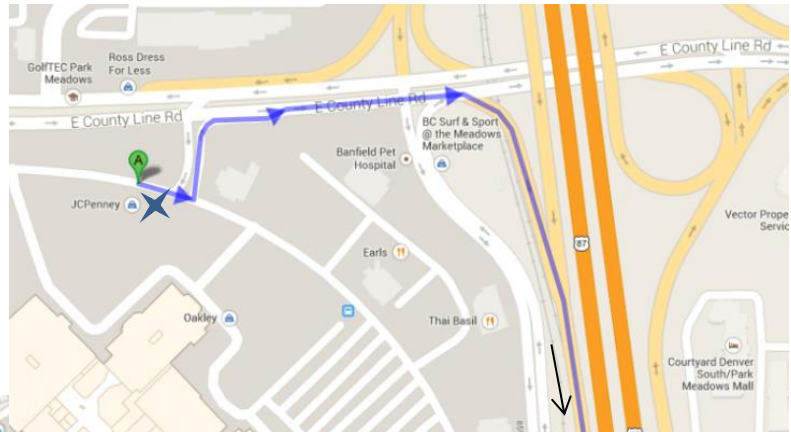
## Denver Caravan Information - 8/9/2013

The Drive 4 Corners BMW meet is kicked off with the departure of the Denver caravan from the Denver area. This document includes the route, meeting points, and schedule. To be part of the caravan, all participants must agree to and sign the Release Waiver for liability reasons (attached).

### **Start Point A:** Denver Meeting Location.

*Meet at 9:30am; depart by 9:45am*

Meet up at the Denver Meeting point in Park Meadows Mall. Meet at the edge of the north-east lot of JC Penney. The caravan will leave from here at 9:45 and start heading south along I-25.



### **Stop B:** Colorado Springs Meeting Location.

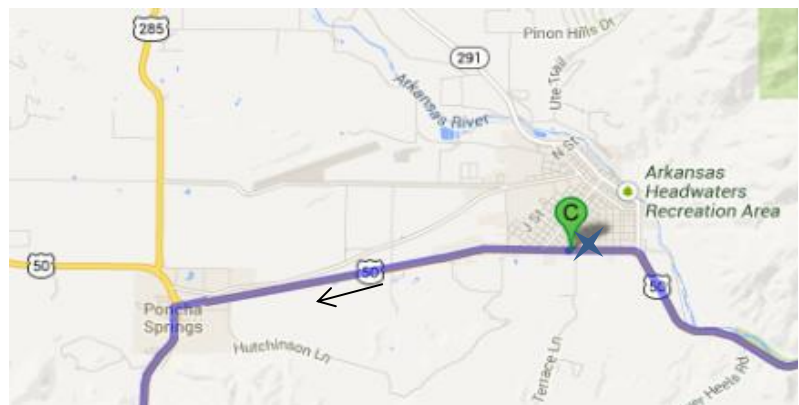
*Meet at 10:45am; depart by 11:00am*

Meet up with the Denver caravan at the World Arena Parking lot. This large lot will be more than adequate for our group size, and allow us easy access to HWY 115. There are a couple of gas stations in the area if needed, primarily along Cheyenne Meadows Road where it meets our route along CO-115.

### **Stop C:** Main rest stop and meeting point in Salida, CO (Loaf N Jug @ 448 E. Rainbow Blvd).

*Meet at 1:00pm; depart by 1:30pm*

All drivers heading south via HWY 285 can meet up with the caravan in Salida, CO. This will be the main rest stop location to use facilities and fill up with gasoline. The Loaf-N-Jug gas station is a central stop in town and sits adjacent to a larger ~20 car empty lot. It sits across from a Burger King and next to a Car Wash.

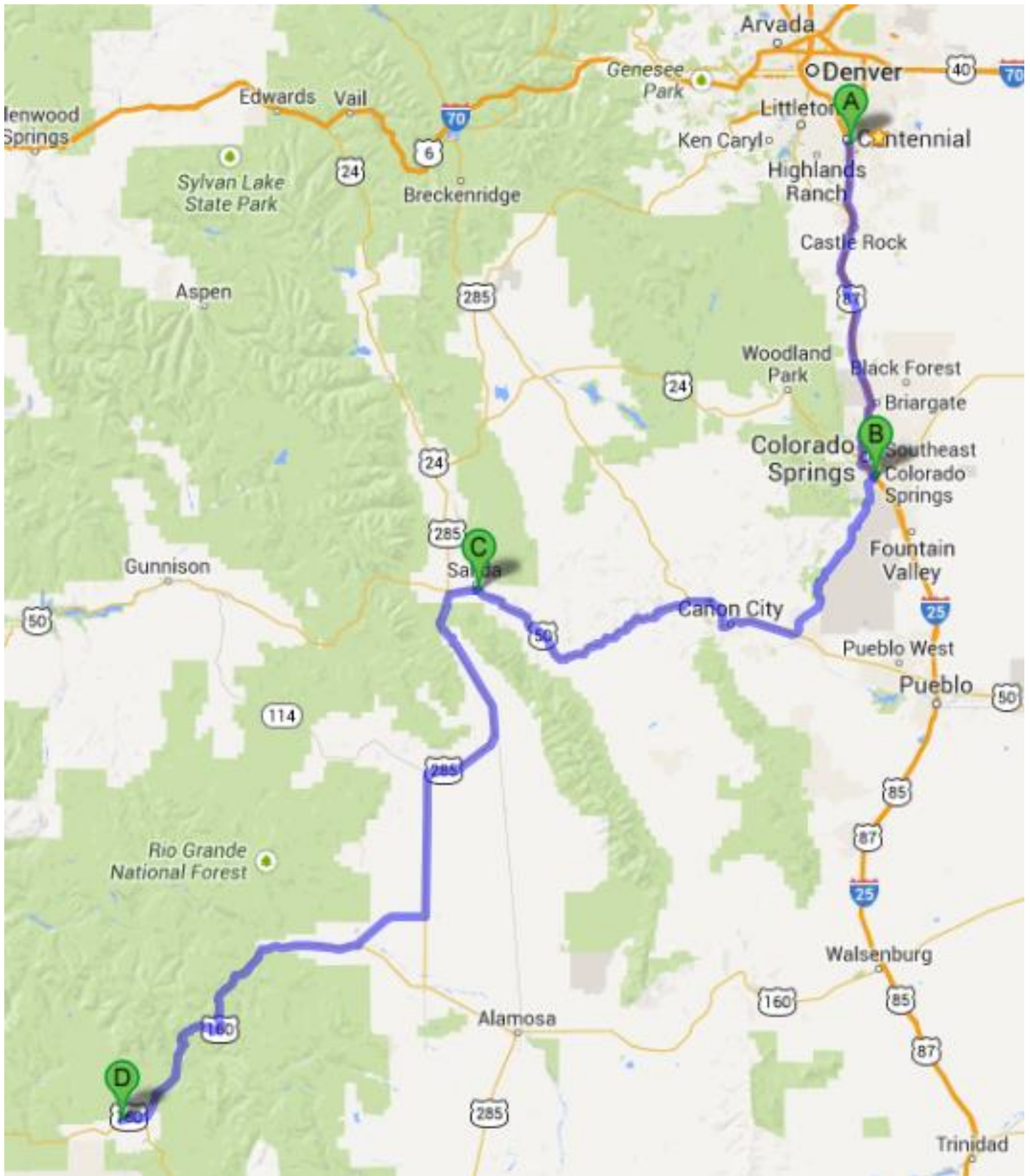

**ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM**

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THIS ACTIVITY OR EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released. (B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration.
