

Arizona Caravan Information - 8/1/2014

The Drive 4 Corners BMW meet is kicked off with the departure of caravans from around the country. This document includes the route, meeting points, and schedule. To be part of the caravan, all participants must agree to and sign the Release Waiver for liability reasons (attached).

TIMES SHOWN IN AZ TIME ZONE (1 Hour Behind CO)

<u>Start Point A:</u> La Encantada Mall – AJ's (2805 E Skyline Dr)

Meet at 6:45am; <u>depart by 7:00am</u>

Meet up at the southern AZ meeting point at the AJ's Parking lot of the La Encantada Mall. Meet and grab breakfast if needed. The caravan will leave from here at 7:00 am to go north along AZ-77 North/Oracle Rd.



<u>Stop C:</u> Holbrook, AZ - Meeting Point/Lunch Stop. Chevron/Woody's Food Stores - 950 Navajo Blvd Meet at 11:30am; <u>depart by 12:00pm</u>


From the prior stop in Globe, the caravan will drive through a nice scenic forest road and Seneca Lake Recreation area; which comes just prior to a nice stretch of winding mountain road and hair pin turns. Then though Show Low, AZ (then turn left on AZ-77 N towards Holbrook). A Chevron/ food store gives us a place to stretch our legs and take a small lunch break (next to Dairy Queen). Stop B: Primary Rest Stop Location Globe, AZ **Super Stop Chevron 1690 E Ash St.**

Meet at 8:50am; depart by 9:05am

Stop break, and meet up with any Phoenix BMW enthusiasts here. This will be a good pit stop after two hours of driving and will make a perfect fuel point. Estimated distance is 135 miles from next stop and 440 miles from Pagosa Springs. Here route turns northeast along US-60 to Show-Low, AZ (turn left onto AZ-77 N).




will also meet the caravan here. From here, we continue northeast along I-40/Route-66/US-491 towards Farmington, NM (204 miles until next stop, 305 to destination).

Stop D: Final rest break – Farmington New Mexico (via Gallup, NM and US-491 across to NM-371)

Arrive at ~3:05pm; depart by 3:30pm

From Holbrook, we will proceed into New Mexico and head north at Gallup, NM via US-491. Then Turn right on Indian Service Route 5 (East) to get to NM-371 North towards Farmington. This will lead the caravan into Farmington for the final stop about 100 miles away from Pagosa Springs. Shell @ 1020 Bisti Highway. Farmington, NM 87401

Follow Aztec Blvd/ US-550 North into Colorado. At US-160, head east towards Pagosa Springs for the last 55 mile leg of the trip.



- (B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration.
