



## Texas Caravan Information - 7/31/2014


The Drive 4 Corners BMW meet is kicked off with the departure of caravans from around the country. This document includes the route, meeting points, and schedule. To be part of the caravan, all participants must agree to and sign the Release Waiver for liability reasons (attached).

### Start Point A: Dallas Meeting Location.

Meet at 5:45am; depart by 6:30am

Meet up at the Dallas Meeting point at the residence **7806 Roundrock Rd.**

Meet and grab breakfast or gas if needed. The caravan will leave from here at 6:30 and start heading west along I-635 for initial 390mi leg.




From Vega, we will drive through Dalhart, Clayton, and a few other towns to **Capulin Volcano National Monument** in New Mexico. A paved path at the top of the extinct volcano gives us a place to stretch our legs on a nice easy hike that is a little over a mile up and around the rim of the volcano (20 minutes). Continue West from here along US-64/US-87 (166 miles until next stop).

### Stop B: Rest Stop Location.

Meet at 12:30pm; depart by 12:45pm

Stop break, and meet up with any other BMW enthusiasts at the **Vega, TX Dairy Queen**. This will be a good pit stop along the journey and fuel point. Estimated distance is 170 miles from next stop and 425 miles from Pagosa Springs. This is where the route turns north along HWY 385.

### Stop C: Rest stop and minor hike.



#### **Stop D:** Dinner stop and rest break

From Capulin Volcano, we will proceed to Raton, New Mexico on I-25 where we go up and over Raton Pass on the eastern side of the Sangre de Cristo Mountains. From Raton Pass on I-25 through Trinidad, Colorado to Walsenburg where we catch Highway 160 west to Fort Garland and the Great Sand Dunes National Park and Reserve. After the dunes onto Alamosa where we can stop at Chili's restaurant and have dinner. **Chili's @ 3231 Main Street. Alamosa, CO 81101** (87 miles remaining)



See map for additional detail. In case you lose the group, be sure to find a 'travelling buddy' that you intend to caravan with for the entire route.





(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity or event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
