

Utah Caravan Information - 8/7/2014


The Drive 4 Corners BMW meet is kicked off with the departure of caravans from around the country. This document includes the route, meeting points, and schedule. To be part of the caravan, all participants must agree to and sign the Release Waiver for liability reasons (attached).

<u>Start Point A:</u> South Town Exposition Center (9575 State Street, Sandy, UT 84070)

Meet at 8:45am; depart by 9:00am

Meet up in Sandy, UT at the meeting point of South Towne Exposition Center. The caravan will leave from here at 9:00 am to go south along I-15 towards Provo.

Spanish Fork: Follow I-15 until Spanish Fork. Take US-6 East towards Tucker, UT.





<u>Green River:</u> Merge onto I-70 East at Green River. Proceed along I70 until Crescent Junction and turn right on US-191 towards Moab, UT.




Stop B: Primary Stop Location

Stop in Moab, UT for gas and or food. After gathering and stretching, the group will leave to head South along US-191 and continue past Moab towards Colorado.



<u>Monticello</u>: At the town of Monticello, turn left onto US-491 towards Colorado and the towns of Calhone, Lewis, and Cortez.



After the town of Lewis, turn left onto CO-184 East. This will bring you to the edge of the mountains on a path towards Mancos, CO and Durango, CO.


At Mancos, CO merge onto US-160 East towards Durango.

The Home Depot, 1301 S Camino Del Rio Durango, CO.

Meet at ~3:30pm; depart by 4:00pm

Stop at The Home Depot in Durango, CO. This stop will provide an easy location to gather for a stretch break and an easy location to find if a bathroom break or gas refill is required. There are a few stores and gas stations nearby for refill.

Once ready to depart, the caravan will continue on US-160 East towards Pagosa Springs. This stop is approximately 55 minutes from the destination.

437 mi – about 7 hours 20 mins



ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THIS ACTIVITY OR EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released. - (A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: The BMW 4 Corners Meet team and/or their administrators, volunteers, representatives, the event holders, event sponsors, and event volunteers.
- (B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity or event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
