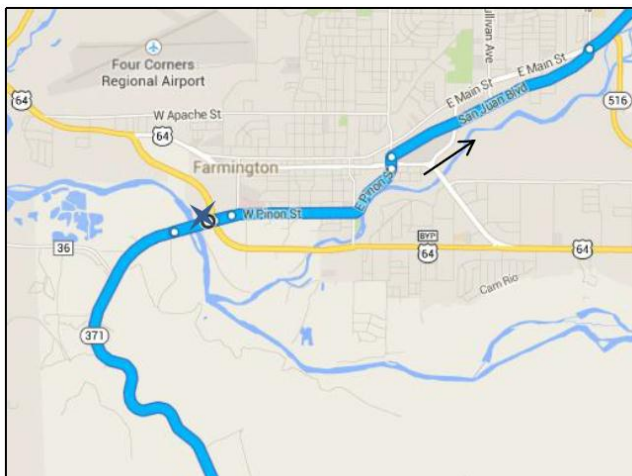
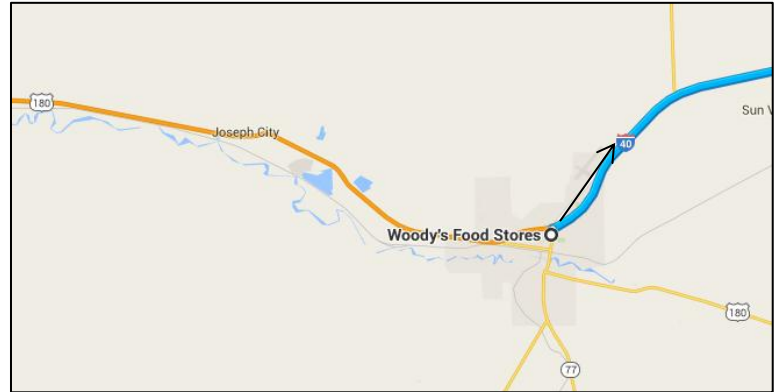
NOTE TIMES ARE SHOWN IN AZ TIME ZONE (1 HOUR BEHIND CO)

Start Point A: Holbrook, AZ - Meeting Point.

Chevron/Woody's Food Stores - 950 Navajo Blvd

Meet at 11:00am; depart by 11:30pm **SHARP**

A Chevron/ food store meeting location gives us a place to refuel and meetup with other participants (next to Dairy Queen). Flagstaff BMW's will also meet the caravan here. From here, we continue northeast along I-40/Route-66/US-491 towards Farmington, NM (204 miles until next stop, 305 to destination).



will lead the caravan into Farmington for the final stop about 100 miles away from Pagosa Springs. **Shell @ 1020 Bisti Highway. Farmington, NM 87401**

Stop C: D4C Caravan meetup. Arrive at ~4:15pm; depart by 4:45pm Follow Aztec Blvd/ US-550 North into Colorado and into Durango. In Durango, turn left on to US550 towards downtown. Stop at the Durango Rec center in the lot on the southwest wide. The lot parallels US 550 and should be clearly visible. GPS address: **Durango Rec Center @ 2424 Main Ave.**

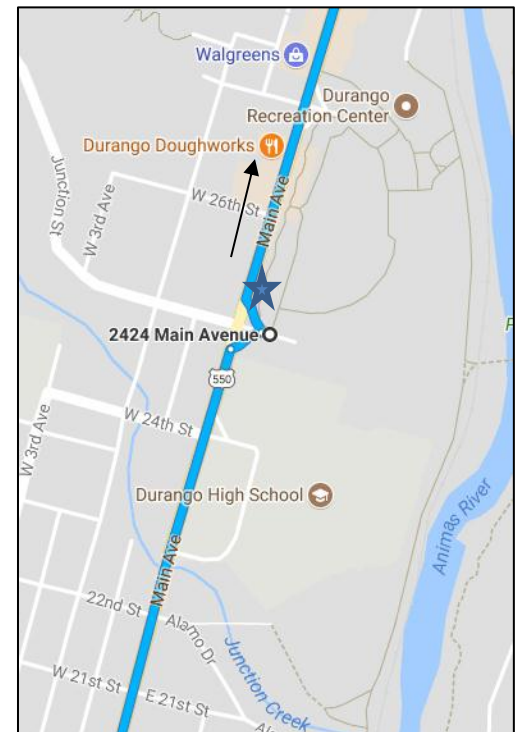
We are encouraging all participants to stop here for a group drive to Purgatory Resort on a 30 minute drive up the two lane road, US 550.

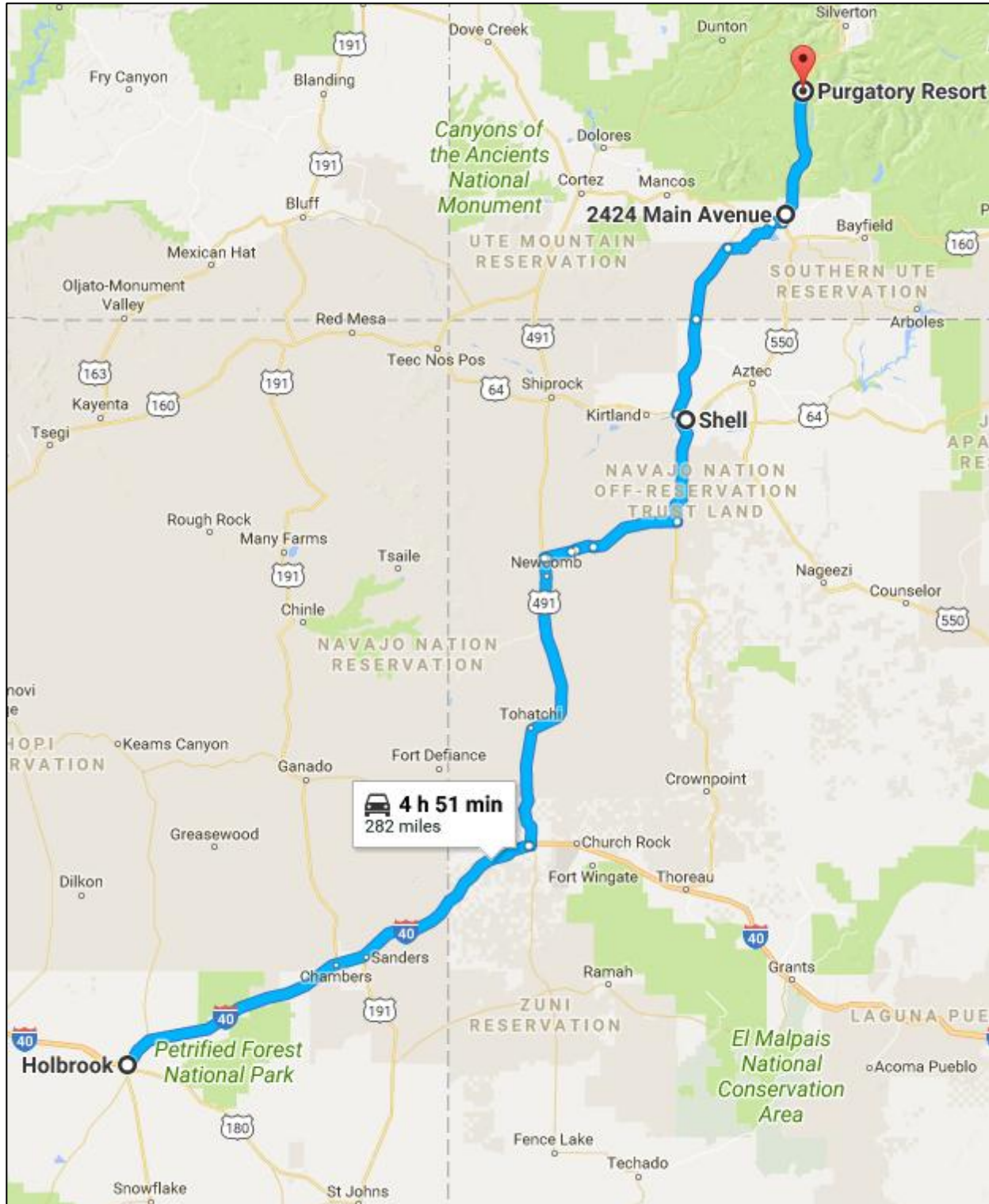

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration.
