



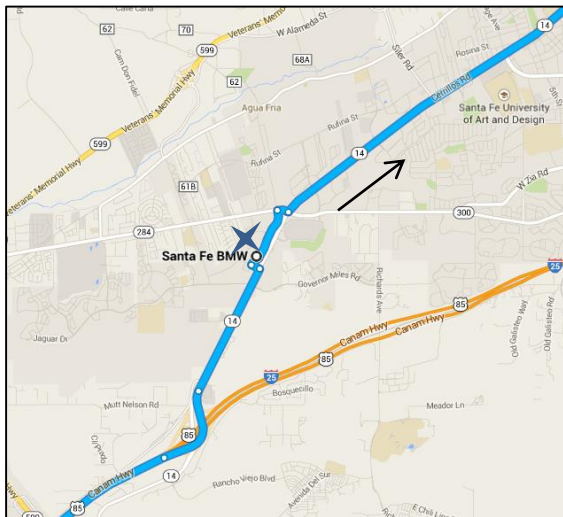
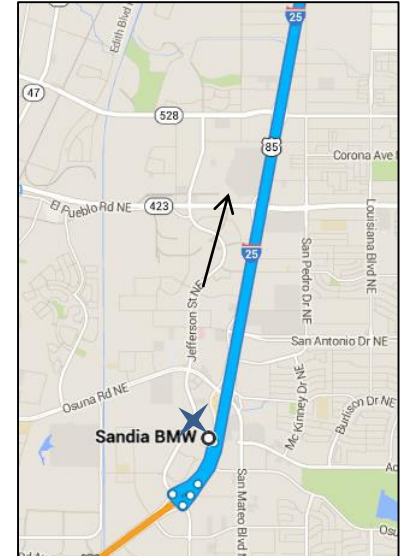
New Mexico Caravan Information - 8/1/2014

The Drive 4 Corners BMW meet is kicked off with the departure of caravans from around the country. This document includes the route, meeting points, and schedule. To be part of the caravan, all participants must agree to and sign the Release Waiver for liability reasons (attached).

Start Point A: Sandia BMW Dealership (6001 Pan American Freeway)

Meet at 11:30am; depart by 11:45am

Meet up in Albuquerque at the Sandia BMW Dealership parking lot. The caravan will leave from here at 11:45 am to go north along I-25 towards Santa Fe and the Santa Fe BMW dealership for refreshments and the like.



Stop B: Primary Stop Location
Santa Fe BMW - 2578 Camino Entrada

Meet at ~12:15pm; depart by 1:15pm

Stop at Santa Fe BMW to meet with fellow BMW enthusiasts and explore the sponsor Santa Fe BMW's dealership. After gathering and mingling with refreshments and such, the group will leave to head North along S St Francis Drive /US-84 W/285.

Optional Stop C: Secondary Stop (19698 US-84)

Stop at the Rio Chama Chevron (past Espanola NM) for a

bladder break. This would be the last stop until Pagosa Springs and US-84. It will be played by ear with the size of the group and urgency for stoppage.

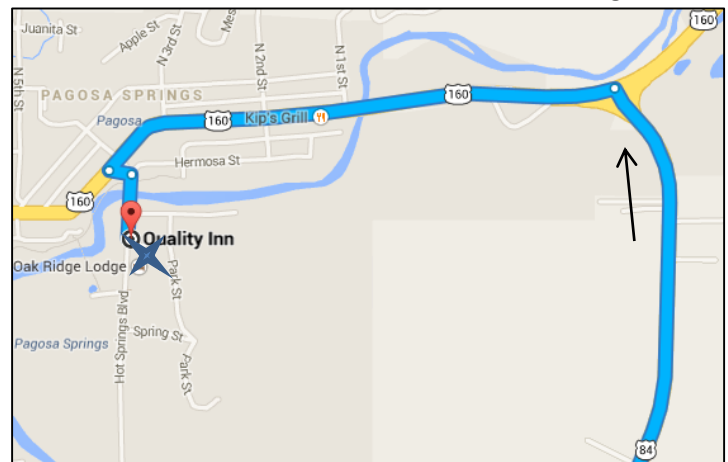
Continuing along US-84 will bring the caravan past Chama, NM and into the state of Colorado. Following US-84 still will bring the group to the edge of Pagosa.

212 mi – about 3 hours 41 mins

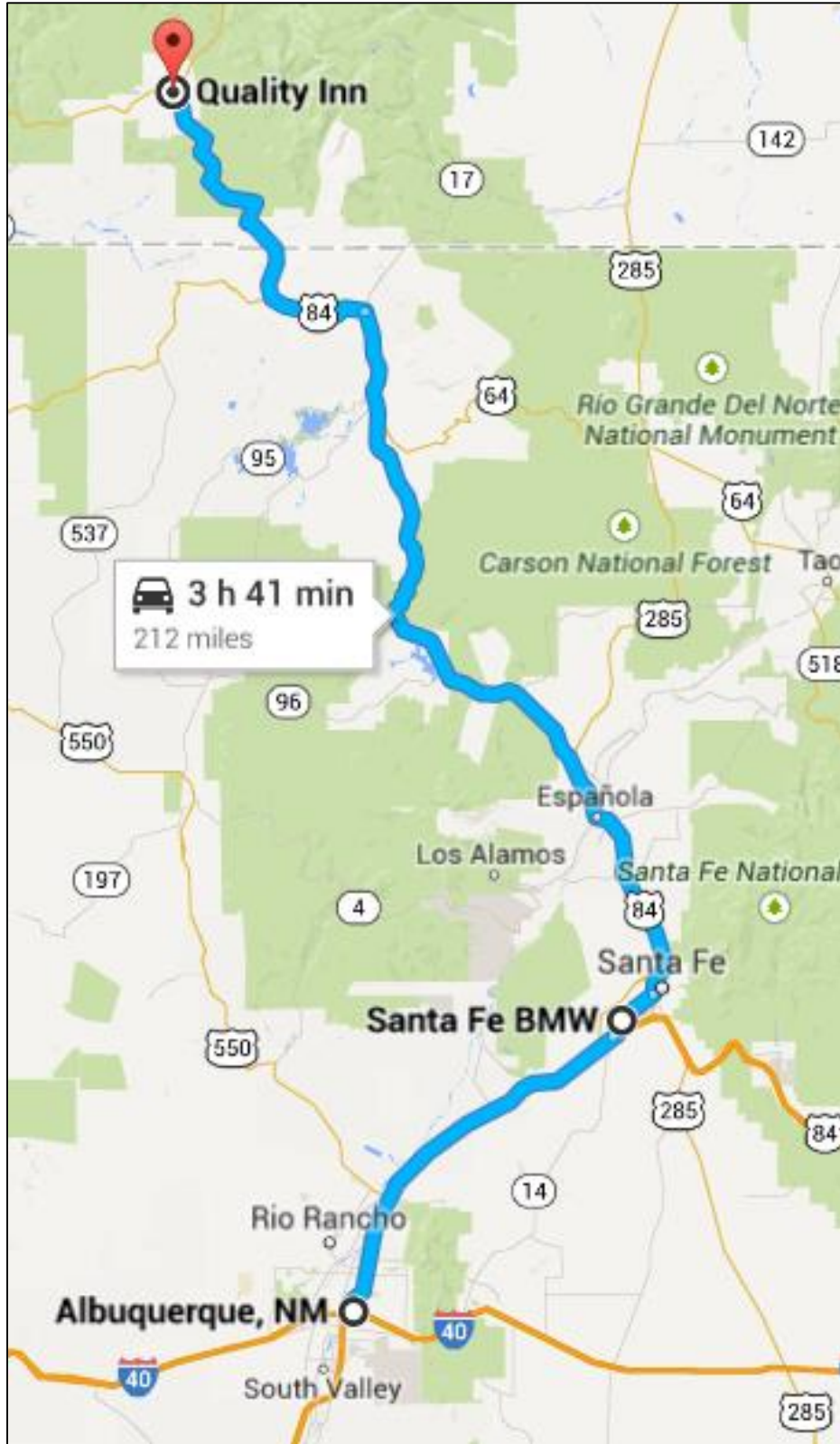
See map for additional detail. In case you lose the group, be sure to find a 'travelling buddy' that you intend to caravan with for the entire route.

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

By registering and/or participating in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: The BMW 4 Corners Meet team and/or their administrators, volunteers, representatives, the event holders, event sponsors, and event volunteers.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that The BMW 4 Corners Meet and/or their administrators, volunteers, representatives, the event holders, event sponsors, event volunteers are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the BMW 4 Corners Meet team.

I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity or event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
